The run-off ballots will be counted by May 10 and candidates will be notified of the results immediately. Should a second tie occur, the Regional Director will cast the tie-breaking vote. All newly elected Delegates will serve terms that will expire on March 31, 2025. The next meeting of the Delegate Assembly is on Saturday, May 20 – Sunday, May 21 and will take place at the Hyatt Regency Hotel in Sacramento.
