1. **Short Term Employees** working more than 20 consecutive days, who work the day before and after a holiday, shall be granted holiday pay.
2. **Substitute Employees** are excluded from holiday pay benefits.

MCOE classified employees assigned to work sites which are closed for winter and spring break will take vacation, Day of Choice or payroll deduction during these periods for days other than those listed above. Exceptions to this rule are subject to the approval of the Primary Department Administrator.

**RESOLUTION OF THE  
MERCED COUNTY OFFICE OF EDUCATION  
CALLING A GOVERNING BOARD MEMBER ELECTION AND  
SPECIFICATIONS OF THE ELECTION ORDER  
TO BE HELD ON NOVEMBER 8, 2022**

**WHEREAS**, the Merced County Board of Education Calls for a Governing Board Member Election to be held on November 8, 2022 (Education Code 5000, Elections Code 12102); and

**WHEREAS**, in accordance with the designations contained in the Specifications of the Election Order made under the authority of Education Code Sections 5304 and 5322, the election shall be held on November 8, 2022, and the purpose of the election is to elect three members of the governing of the board of Merced County Office of Education; and

**WHEREAS**, Merced County intends to conduct a consolidated election with the Statewide Presidential General Election to be held on November 8, 2022 (Elections Code 10400); and

**WHEREAS**, the consolidation of elections may serve to reduce election expenses to taxpayers and may increase voter turnout; and

**WHEREAS**, a Notice of Election must be filed with the Merced County Registrar of Voters specifying which offices are to be filled at this election (Education Code 5324, Elections Code 10522); and

**WHEREAS**, the list of incumbents and terms of office will be submitted to the Merced County Registrar of Voters; and

**WHEREAS**, a Candidate's statement pursuant to Elections Code 13307, if desired is to be paid by the Candidate; and

**WHEREAS**, the Merced County Board of Education of the Merced County Office of Education adjusted their trustee area boundaries following the 2020 U.S. census figures in compliance with applicable state and federal law (Education Code 5019.5); and

**WHEREAS**, a pre-determined tie-breaking method is designated to prevent any possible dispute as to the final outcome of the election (Elections Code 10551); and

**WHEREAS**, the Merced County Elections Department is authorized to conduct the election and to canvass all returns pursuant Elections Codes 10411-10413; and

**WHEREAS**, Merced County will be reimbursed for the actual costs of the election (Elections Code 10002, 10520); and

***NOW, THEREFORE, IT BE RESOLVED***, that the Merced County Board of Education, of the Merced County Office of Education, City of Merced does hereby:

1. Calls for an Election to be held to elect three members of the governing board of Merced County Office of Education;
2. Request that its Governing Board Member Election to elect two seats for Trustee Area 1, 2, and 5 be Consolidated with the Statewide Presidential Election scheduled for November 8, 2022;
3. File its Notice of Election with the Registrar of Voters specifying the elective offices to be filled;
4. Submit a list of incumbents and terms of offices;
5. Require that a Candidate's Statement, if desired, is to be paid by the Candidate;
6. Certify the current Trustee area boundary maps;
7. Sets a drawing of lots as its tie-breaking method for this election with procedures as previously established by Merced County Office of Education in Board Bylaw 9220 - County Board Elections, adopted on December 14, 2020;
8. Authorizes Merced County Elections Department to conduct the election and canvass the returns;
9. Intends to reimburse Merced County for the actual costs of this election.

**RESOLUTION OF THE BOARD OF EDUCATION OF THE  
MERCED COUNTY OFFICE OF EDUCATION  
AUTHORIZING THE SALE OR DISPOSAL OF SURPLUS PROPERTY  
Furniture, Equipment, Vehicle and Other Surplus Properties**

**WHEREAS**, the Merced County Office of Education (MCOE) finds that the furniture, equipment, vehicles and other surplus properties on the attached list is obsolete, damaged, or is no longer needed for the MCOE's educational programs; and

**WHEREAS**, the property to be sold has been approved for sale or disposal by the assistant superintendent of the MCOE department requesting the disposal of the property; and

**WHEREAS**, no item on the list has a value greater than \$25,000 and therefore no appraisal is needed per Education Code Sections 1279; and

**NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED** by the Merced County Board of Education of the MCOE as follows:

- Section 1. That the above recitals are true and correct.
- Section 2. That the Merced County Board of Education hereby declares the Property as surplus.
- Section 3. That the Merced County Board of Education directs the County Superintendent or Assistant Superintendent of Business Services, to conduct or supervise the sale of these items and other surplus property so authorized by MCOE assistant superintendents, subject to the terms of MCOE's standard surplus property procedures. Items that are not sold are authorized to be disposed of in the Merced County landfill or donated to another school district, public agency, or charitable organization, as applicable.

#### Analysis Measurement, and Accountability Reporting Division (AMARD)

Alternative schools of choice and charter schools who are currently not participating in the Dashboard Alternative School Status (DASS) program or DASS schools who are up for their 3-year DASS cycle renewal must complete a two-part application process to be considered for DASS participation. This online survey is Part 1 of the DASS application process and requests information about the school's high-risk student population. This survey should be completed by the school's designated DASS Coordinator who will serve as the liaison between the school and the California Department of Education (CDE) DASS Team. Once the survey is completed, the DASS Coordinator will receive an email within two business days containing instructions for completing Part 2 of the application.

To be eligible for DASS status, schools must have an unduplicated count of high-risk students that comprise at least 70 percent of the school's total enrollment. (Note: a student must meet one of the high-risk criteria upon first entry into the school). **Complete all fields before submitting.**

Part 2 asks for the electronic submission of specific supporting documents, including Local Governing School Board or charter governing board approval, to the CDE DASS Team through an online document mailbox using Box.com. Once Part 1 has been completed, the DASS Coordinator will receive an e-mail containing instructions for accessing their school's Box.com electronic folder and uploading their supporting documents.

The deadline for submitting Part 1 of the DASS for the 2022 California School Dashboard release is **February 28, 2022**. The deadline for submitting Part 2 is **June 30, 2022**.

**Note:** Approval of DASS participation is contingent upon completion of Part 2. It is recommended that the DASS application be placed on the local board agenda once the CDE box.com folder invitation for Part 2 supporting documents is accepted.
